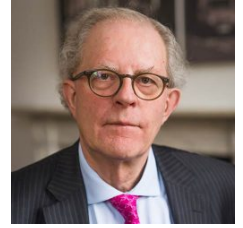

James Goudie KC

Commercial / Arbitration & Mediation

James is a Fellow of the Chartered Institute of Arbitrators. He is experienced both as an Arbitrator and appearing as Counsel in arbitrations and mediations. He appears in the Commercial Court, the Technology and Construction Court, the Chancery and Queen's Bench Divisions and Tribunals.

Employment

An employment tribunal had been wrong to refuse a journalist access to copies of skeleton arguments, witness statements and trial bundle documents that had been referred to in a hearing which he had not attended.

Public

Public, administrative and constitutional law is James' main area of practice. He is co-editor of a leading textbook on judicial review and has appeared in very many of the major judicial review cases. He is a Past Chair of the Administrative Law Bar Association.

whether exclusion of public from Cabinet Meeting was unlawful and **Westminster City Council v Sports and Leisure Management Ltd** (2021) EWHC 114 (TCC) – contractual allocation of risk in respect of losses under leisure services contract arising from covid-19 change in law.

Education

James is an Emeritus Governor of the London School of Economics. He has appeared in many important education cases, including on college transport, nursery education, and admission criteria.

European Union

James is a Past Chair of the Bar European Group. He is heavily involved not only with public procurement, competition and State Aid, but also with EU aspects of environmental and employment law and retained EU Law generally.

Health & Community Care

James has appeared in many cases related both to the NHS and to community care, including **R (F) v Buckinghamshire County Council** (2019) EWHC 1817 (Admin) on closure of children’s centres and consultation.

Recent cases include **R (Lancashire County Council) v SoS for Health and Social Care** (2021) EWHC 268 (Admin), (2021) 24 CCLR 57, dispute between two local authorities as to which of them had responsibility for funding accommodation for an individual who had suffered brain damage.

Human Rights

James’ practice extends to the European Court of Human Rights.

Information, Media & Privacy Law

James is a former President of the National Security Panel of the Data Protection and Information Tribunal. He represented the then Information Commissioner before the Bichard Inquiry on data processing issues arising out of the Soham Murders, and acted for the Commissioner in the High Court in the case over MP’s expenses. He deals not only with data protection but also with environmental and other information requests, freedom of expression, privacy and confidentiality.

Recent cases include **Garrard v Information Commissioner and British Museum** (2024) UKFTT 601 (GRC), freedom of information, corporate sponsorship and fossil fuels and **Hussain v Sandwell MBC** (2017) EWHC 1641 (Admin), [2017] ACD 97 on data protection.

Local Government

James has been nicknamed “the Godfather of Local Government”. He was the Leader of a London Borough. Recent cases include **London Borough of Merton Council (Appellant) v Nuffield Health (Respondent)** [2023] UKSC 18 on rating relief for charities, **Chillardara Group Holdings Ltd v West Northamptonshire Council** [2023] EWHC 1675 (Admin) (05 July 2023) on local authority land disposals, **Williams v Caerphilly Council** (2020) EWCA Civ 296, CA, March 3 2020, [2020] PTSR 1130 on local authority decision making, **R (Peters) v Haringey LBC** [2018] HLR 33; [2018] PTSR 1359; [2018] WLR (D) 74; (2018) EWHC 192 (Admin) on vires, **R (Whitstable Society) v Canterbury City Council** (2017) EWHC 254 (Admin) on land disposal, **R (Hussain) v Sandwell MBC** [2017] WLR (D) 438; [2018] PTSR 142; (2017) EWHC 1641 (Admin) on standards, and **R (Liverpool City Council) v SoS** [2017] PTSR 1564; [2017] WLR (D) 314; (2017) EWHC 986 (Admin) on central government funding of new burdens on local authorities.

Procurement & State Aid

Procurement

James has acted in numerous public procurement cases and is a much sought after source of advice on

all public procurement issues. His recent cases include **Ocean Outdoor UK Ltd v Hammersmith & Fulham LBC** [2019] WLR (D) 555; [2020] 2 All ER (Comm) 213; [2020] 2 All ER 966; (2019) EWCA Civ 1642, [2020] PTSR 639, the leading case on concession contracts and the land exemption.

State Aid/Subsidy Control

James has acted throughout the Ricoh Arena saga, **R (Sky Blue Sports & Leisure Ltd) v Coventry City Council**, No. 1 on a loan, and No.2, on a lease extension, both at first instance and in the Court of Appeal, the leading cases on State Aid and the Market Economy Investor Principle, now embodied in the Subsidy Control Act 2022.
