## Professional Discipline & Regulatory

Her experience includes advising on regulatory investigations, enforcement action, prosecuting and defending allegations of professional misconduct in disciplinary tribunals and acting in judicial review claims and statutory appeals both challenging and defending regulatory decisions. Heather has deep sector-specific expertise in relation to professionals providing services in the legal, financial and healthcare spheres and also has a wide range of experience of cases involving industry regulators including bodies such as the Information Commissioner and the Gambling Commission.

Heather has particular expertise in legal regulation and is a highly sought after junior in this field. She has extensive experience of acting for both professional disciplinary bodies and regulated individuals and entities.
